ANNOUNCEMENT OF OFFER PRICE AND ALLOTMENT RESULTS

SUMMARY

Offer Price and Net Proceeds

- The Offer Price has been determined at HK\$1.0 per Offer Share (excluding brokerage of 1%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).
- Based on the Offer Price of HK\$1.0 per Offer Share, the net proceeds from the issue of the Offer Shares under the Global Offering to be received by the Company, after deducting the underwriting commission and other related expenses payable by the Company in connection with the Global Offering, are estimated to be approximately HK\$87.5 million. The Company intends to apply such net proceeds from the Global Offering in accordance with the purposes set out in the section headed “Future Plans and Use of Proceeds” in the Prospectus.

The Hong Kong Public Offering

- The Hong Kong Offer Shares initially offered under the Hong Kong Public Offering have been very significantly over-subscribed. A total of 19,370 valid applications have been received pursuant to the Hong Kong Public Offering on **WHITE** and **YELLOW** Application Forms and through giving **electronic application instructions** to HKSCC via CCASS and through the **HK eIPO White Form** service (www.hkeipo.hk) for a total of 625,358,000 Hong Kong Offer Shares, representing approximately 50.03 times of the total number of 12,500,000 Offer Shares initially available for subscription under the Hong Kong Public Offering.
- As the very significant over-subscription in the Hong Kong Public Offering was more than 50 times but less than 100 times of the number of Offer Shares initially available under the Hong Kong Public Offering, the reallocation procedures as described in the section headed “Structure and Conditions of the Global Offering — Reallocation of the Offer Shares” in the Prospectus have been applied. A total number of 37,500,000 International Offer Shares have been reallocated from the International Offering to the Hong Kong Public Offering. As a result of such reallocation, the final number of Offer Shares allocated to the Hong Kong Public Offering is 50,000,000 Shares, representing 40% of the total number of Offer Shares available under the Global Offering.

The International Offering

- The International Offer Shares initially offered under the International Offering have been slightly over-subscribed by approximately 0.26 times of the total number of 112,500,000 Offer Shares initially available for subscription under the International Offering. The final number of International Offer Shares allocated to 184 places under the International Offering is 75,000,000 Offer Shares, representing 60% of the total number of Offer Shares initially available under the Global Offering.

Cornerstone Investors

Pursuant to the Cornerstone Investment Agreements with the Cornerstone Investors as disclosed in the section headed “Cornerstone Investors” in the Prospectus, the number of Offer Shares subscribed for by the Cornerstone Investors has now been determined. South Pacific has subscribed for 45,000,000 Offer Shares, and Mr. Chen Xiangeng has subscribed for 10,000,000 Offer Shares, in all totaling 55,000,000 Offer Shares, representing approximately (i) 44.0% of the total Offer Shares; and (ii) 11.0% of the total Shares in issue upon completion of the Global Offering. The Directors confirm that, to the best of their knowledge, information and belief and having made all reasonable enquiries, all placees and the public who has subscribed for the Offer Shares and their ultimate beneficial owners are independent of and not connected with the Company and any of the Directors, chief executive, Controlling Shareholders, substantial shareholders or existing Shareholders (as defined under the Listing Rules) of the Company or any of its subsidiaries or their respective close associates (as defined under the Listing Rules), and are not any person or group of persons stated in paragraph 5 of Appendix 6 to the Listing Rules or any nominees of the foregoing, and none of the Offer Shares subscribed by the placees and the public who has subscribed for the Offer Shares have been financed directly or indirectly by any of the Directors, chief executive, Controlling Shareholders, substantial shareholders or existing Shareholders (as defined under the Listing Rules) of the Company or any of its subsidiaries or their respective close associates, and none of the placees and the public who has subscribed for the Offer Shares is accustomed to taking instructions from any of the Directors, chief executive, Controlling Shareholders, substantial shareholders or existing Shareholders (as defined under the Listing Rules) of the Company or any of its subsidiaries or their respective close associates in relation to the acquisition, disposal, voting or other disposition of the Shares registered in his/her/its name or otherwise held by him/her/it. Based on the Offer Price of HK\$1.0 per Offer Share and 125,000,000 Offer Shares, the net proceeds from the Global Offering to be received by the Company, after deducting the underwriting commission and other related expenses payable by the Company in connection with the Global Offering, are estimated to be approximately HK\$87.5 million.

The Company intends the use such net proceeds for the following purposes:

- approximately HK\$30.5 million (or approximately 34.8% of our net proceeds) will be used for financing the upfront cost to manage the cash flow mismatch between salaries payment and collection of sales receipt;
- approximately HK\$16.6 million (or approximately 19.0% of our net proceeds) will be used for enhancing our operational efficiency and quality of our environmental hygiene service by upgrading our hardware and software as well as recruiting additional talents mainly for contracting and operation department;
- approximately HK\$15.2 million (or approximately 17.4% of our net proceeds) will be used for acquiring suitable new specialised motor vehicles for rendering environmental hygiene service;
- approximately HK\$14.9 million (or approximately 17.0% of our net proceeds) will be used for development of waste management business including, among others, to develop or acquire businesses related to waste management such as running of fleets;
- approximately HK\$5.1 million (or approximately 5.8% of our net proceeds) will be used for the purchase of suitable new automated cleaning machineries and equipment mainly for rendering environmental hygiene service; and
